## JUDGMENT

The $1^{\text {st }}$ petitioner is aggrieved by seizure of cash from his premises. He has a case that he had stopped business years back and is not an assessee whose premises need to be inspected and property subjected to seizure. It is also submitted that no purpose is served by seizing cash. The 1 st petitioner has some explanation about the source of the cash which has been seized.
2. The Senior Government Pleader on instructions submits that the quarrying was being carried out both in the individual name as well as in the name of a firm and on getting information regarding some irregularities, the inspection was carried out which resulted in the seizure. It is submitted that subsequent procedure is under process and even the value of available stock of granite is to be determined.

WP(C) NO. 39406 OF 2022

I do not think it is proper for this Court to interfere at this stage and direct release of the cash, which is primarily a matter which has to be considered by the Authorities concerned. The $1^{\text {st }}$ petitioner has preferred Ext.P11 application before the $1^{\text {st }}$ respondent. The writ petition is hence disposed of directing the $1^{\text {st }}$ respondent to consider and pass orders on Ext.P11 after hearing the petitioners at the earliest, at any rate within three weeks from the date of receipt of a copy of this judgment.
